During the past five years, several National Designated Authorities (NDAs) of the OECD schemes for certification have been requesting that the GM status of a variety should be indicated on the OECD list of cultivars, in order to facilitate communication between NDAs and to ensure that national legislation regarding GM varieties is complied with. In order to take into account commercial practices and to facilitate the communication between NDAs, ISF will now accept the indication that a variety is a GM variety on the OECD list of varieties, for internal governmental use.
