City Council to look into the possibility of privatizing the ambulance service to make sure they are taking a look at the cost of the service to be confident they are running it the best way.

"I wanted to make sure we are doing the right thing," Courchesne said. "To make sure we are doing things the most efficiently and fiscally responsible [way]."

Chief Desmarais said the ambulance service the city has right now is the "best method in the environment we are in."

He said that while privatizing the emergency medical dispatch (EMD) would save the city a bit of money, "the services the ambulance is providing is a little better than available in a private fashion, and the city having control over the service means we can also control response time."

"Running your own department, you have total control. I think the cit-

izens receive a terrific service; they expect that service and are willing to absorb that extra additional cost. We provide a very good service with 100 percent of control," Chief Desmarais said.

"Our response times are very low because [our ambulances] are in our firehouses. They are located in the city, and we have sufficient back up," he added.

A Personal Representative appointed under the MUPC in an unsupervised administration is not required to file an inventory or annual accounts with the Court. Persons interested in the estate are entitled to notice regarding the administration directly from the Personal Representative and may petition the Court in any matter relating to the estate, including the distribution of assets and expenses of administration.
