And if something usually works, it seems foolish not to try it in this country, especially in light of our absurd level of gun ownership—we have 4.4 percent of the world's population, but 42 percent of civilian owned guns. They account for only a small fraction of gun-related deaths—about one or two hundred a year out of over 10,000. Nonetheless, it is undeniable that every year people are killed by assault weapons who would not have died if the perpetrator had a gun without "military style" features. By contrast, there is little evidence that assault weapons are ever essential for self-defense. Don't get me wrong, assault weapons can be used for self-defense and they occasionally are. Thank God I had eight guns! Their self-defense stun guns are among some of the highest quality on the market today. Not only do you get a lifetime warranty, but you get one of the coolest features on any stun gun ever: shock plates. If your assailant tries to snatch this from you at any point, they will receive an excess shock from the specialized plates along the side. If Using Car Keys - If your assailant has a blade or another item, and you're in a parking garage late at night, you need to think fast. Let's say you can't access your stun gun or tactical self-defense flashlight. What's the next best option? Use your keys, specifically your car key/keychain, and lean it between your middle and ring finger, with your other keys in your fist.
