Up until this point in American history, around the 1920s, there was no such thing as a marriage license. The states invented them as a way to dictate who could and could not get married for the purpose of making sure blacks, whites, Asians and Indians didn't mix. That's right. Marriage licenses were invented as a way to stop white people from marrying black people. Because they couldn't get a license, interracial couples who would have been considered married before the marriage license was available, ceased to be married. They lost inheritance rights, medical rights and all other benefits o
