This data set allows us to examine both the antecedents and consequences of the contribution process. We also propose a new measure that captures both the amount and the timing of others's contribution behavior: contribution frequency (dollars per unit time). The term "dislocated workers" refers to persons permanently separated from their jobs and connotes the disappearance of the job as well as the dislocation of the individual workers from the enterprise.
