Applied Behavior Analysis (ABA) is a therapy based on the science of learning and behavior. Behavior analysis helps us to understand: How behavior works. How behavior is affected by the environment. How learning takes place. ABA therapy applies our understanding of how behavior works to real situations. Applied Behavior Analysis involves many techniques for understanding and changing behavior. ABA is a flexible treatment: Can be adapted to meet the needs of each unique person. Applied behavioral analysis is an intensive therapeutic approach in which the applied behavioral analyst carefully documents behaviors in a systematic manner. The analyst will first observe the child or other behavior-disordered person in a variety of settings, carefully documenting behaviors. She will also conduct a series of interviews with the caregivers, health professionals, teachers, parents and others who have important roles in the person's life.
